### By-law #25-02

#### Article 1

The general property tax rate is set at \$0.43/\$100.00 for the year 2026, in accordance with the assessment roll in effect on January 1, 2026.

#### Article 2

Garbage collection fees are as follows:

Occupied residence:	\$200.00
Local business:	\$250.00
Occupied residence:	\$150.00

#### Article 3

The interest rate applicable to all taxes, compensation, permits, or receivables owed to the municipality is now set at 12% per annum. These are charged using a variable method, effective January 1, 2026.

#### Article 4

This by-law shall come into force in accordance with the law.

This by-law was adopted on December 1, 2025.
