**By-Law #21-05****Article 1**

The property tax rate is set at \$.55/\$100.00 for the year 2022 to comply with the evaluation roll that comes into effect on January 1<sup>st</sup>, 2022.

**Article 2**

The tax rate for garbage is set at:

**Article 3**

The recycling tax is set at:

**Article 4**

The interest rate on all taxes not paid to the Municipality within the delays specified is set at 12% and is charged at the variable method, starting on January 1<sup>st</sup>, 2022.

**Article 5**

The present By-Law will enter into effect according to the law.

The present By-Law was adopted on December 20<sup>th</sup>, 2021.
