Garbage and recycling bins at the Community Center

By-Law #23-07

Article 1

The property tax rate is set at \$.55/\$100.00 for the year 2024 to comply with the evaluation roll that comes into effect on January 1st, 2024.

The tax rate for garbage is set at:

Local Businesses
Per household with occupancy of less than 6 months per

The recycling tax is set at:

Article 4

The interest rate on all taxes not paid to the Municipality within the delays specified is set at 12% and is charged at the variable method, starting on January 1st, 2024.

Article 5

The present By-Law will enter into effect according to the law.
